DISCUSSIONS

WATER DELIVERIES & OPERATIONS: Chris Muller provided an update on water deliveries and planned operations. The current offer is 6 MGD. The membership met the take-or-pay obligation for the 2024/2025 WISE year on May 29th. The WISE sanitary survey was conducted on May 23rd. There were no violations and just a few minor recommendations. WISE will be coordinating with members to do a half day shut down for each connection to do ethernet conversions for flow meters.

BINNEY CONNECTION: Kate Bandel presented an update on the Binney Connection Project. Tetra Tech continues to work with Aurora Water SCADA on the IO list. Tetra Tech is making the PLC modification this week, and it will be inspected next week prior to UL certification. XCEL has reenergized the electrical service line.

DIA CONNECTION UPDATE: Kate Bandel presented an update on the DIA Connection. The contractor has installed about 32,371 ft. of pipeline (96% complete). The site acceptance testing for the flow control building is scheduled for the week of July 7th. CDPHE approved Aurora to accept the DIA water into the Prairie Water Systems on May 29th. Staff anticipate a project completion late July.

SALINITY MANAGEMENT: Chris Muller provided an update on Salinity Management. Pipeline alternatives study has kicked off. WISE toured the ECCV pellet softening pilot. WISE will continue to discuss with ECCV as the pilot progresses.

WEB PORTAL UPDATE: Kate Bandel provided an update on the web portal. Hazen continues to advance the web portal programming. Current efforts have focused on calculations regarding capacity system checks.

OTHER BUSINESS: Ken Lykens shared his departure of the WISE Board as he leaves Shea and Meridian Metro District for a new role.
