BINNEY CONNECTION:

Chris Muller presented an update on the Binney Connection Project with photos showing completed work on the pipeline, including the casing at Aurora Parkway.

Chris Muller provided a change order update for the pipeline work being done by T. Lowell. The change orders today total \$337,085.87 (2.41% of the original contract).

Cyber Security Q&A with Tony Petrucci: Tony answer questions from staff and the Board regarding cyber security measured used on the WISE system.

WATER DELIVERIES AND OPERATIONS: Chris Muller explained that WISE members are currently accepting the full 6.5 MGD offer for the remainder of May. WISE is still on track to meet take-or-pay for the 2021/2022 WISE year on May 30th. Chris will provide updates in May regarding the take or pay status.

The Stonegate 10" flow meter has been serviced and is still misreading. A replacement flow meter will be ordered and installed.

Aurora initially offered 5,000 AF year for 2022/2023 WISE year, but now wants the option to deliver us 3,000 AF. An update offer table will be sent out that breaks down the 3,000 AF offer for the 2022/2023 WISE year.
